



Initial certification and accreditation of educational activities

- Goal: minimum standard
- Single educational activities
 - All joint & shared courses
 - Syllabus/Course description in student portal
- Joint programmes
 - Cooperation agreement incl. committee for QA & QE
 - Self-description according to European Approach


Example: Student Survey Level 1



Quality Assurance of Teaching and Learning at the University of Warsaw

- Current system established in 2019 as a result of a big change in higher education regulations at national level.
- Focus changed from the level of the faculty to the level of study programme



Actors of the current system

Study program level

- Director of Teaching and Learning
- Head of Studies
- Education Council
- Chaired by Director of Teaching and Learnig of the unit organizing the study program or elected

University Level

- Rector
- Senate
- Vice-Rector for Students and Quality of Teaching
- Rector's Deputy for Quality of Teaching and Learning
- University Council of Education
- •Office of Innocation in Teaching and Learning
- Quality Assurance Research Unit (PEJK)
- Team for Quality of Education
- Advice Point for Quality of Teaching and Learning



External quality assurance

- Polish Accreditation Committee (PAC)
 - National Agency created for external evaluation in form of accreditation of 1st, mono and 2nd cycle studies.
 - Each study program is accredited by a team led by member of the PAC and consisting of other members or experts in the field, experts in QA systems, stakeholder expert and 1 student.
 - Each visitation is preceded by University writing a self-evaluation report on organising a particular study program including the approach to the QA.
 - Currently concentrates on study program level but soon will introduce
 Complex Evaluation which will be kind of institutional evaluation.



QM and 4EU+QUALITY at University of Warsaw

- Cooperation: Office for Innovation in Teaching and Learning -> Education Quality Evaluation Unit (members of the Teaching and Learning Support Centre) + 4EU+ Local Office
- Coordination: 4EU+ representative for UW in the 4EU+ on quality management (QM group)
- Ca. six colleagues involved
- Regular meetings + email exchange
- Reporting to the Rector's Plenipotentiary for Quality of Education



Status Quo

- Surveys are administered as part of regular course surveys
- Piloting stage
 - Surveys are active since the end of May
 - Reponse rates too low? Consider surveying students during the last class
 - Information about surveys sent to both lecturers and students
 - Surveys available on PCs and mobile phones




QM System at Heidelberg University

- 2009: holistic QMS under the Vice-Rector Quality
 Development
- 2014 2020: system accreditation
- Since 2016: heiQUALITY Office
- 2020 2028: re-accreditation

Status Quo

- Surveys are administered as part of regular course surveys
- Mixed results
 - High-response rates for stays abroad
 - For course-level: need to improvement
- Key Performance Indicators are collected by local office


